Thank you for contacting CITB requesting information under the Freedom of Information Act (FOIA). Your email, dated 7 July 2020, asked for the following information:

- 1. How many people are employed by your organisation, including full time and part time?
- 2. What is your current intranet solution? (SharePoint, WordPress, Invotra, etc)
- 3. How long have you been using this intranet solution?
- 4. When is your intranet contract up for renewal?
- 5. What is your annual intranet budget?
- 6. Do you share an intranet/IT services with other organisations, if so who?
- 7. Which team and/or individual(s) are responsible for managing your intranet internally?
- 8. Are you using the Office 365 suite? If so, which applications from the suite are in use?
- 9. Which team and/or individual(s) are responsible for your intranet's procurement within the organisation?
- 10. Is your Active Directory hosted on-premise, or in the cloud?
- 11. Could you provide us with a link to your Digital Workplace Strategy?

My response is as follows:

1. At the time of the request the number of people employed by CITB is: Total employees = 812

Full Time = 754

Part Time = 58

Contractors = 12

2. CITB's current Intranet solution is SharePoint Online.



- 3. CITB has been using the Office 365 suite of solutions for around 2 years.
- 4. The intranet contract up for renewal annually.
- 5. There is no annual intranet budget.
- 6. CITB does not share intranet/IT services with other organisations.
- 7. The team responsible for managing our intranet internally is the CITB Digital Team.
- 8. We are using Office 365 suite and the following applications are in use within the Office 365 suite: MSOffice, SharePoint, Skype for Business, Teams, Yammer, MS Dynamics, One Drive, MS Flow, Power BI, Power Automate.
- 9. SSCL, our outsourced partner, carry out procurement activity on our behalf.
- 10. Our Active Directory is hosted on-premise, with a copy synced to Azure AD.
- 11. We are not able to provide you with a link to our Digital Workplace Strategy; we are however able to provide a copy of this strategy document (see Appendix A).
