Freedom of Information Request: 372019

Thank you for contacting CITB requesting information under the Freedom of Information Act (FOIA). Your email, dated 29 January 2020, asked for the following information:

The 2018/2019 accounts state that there were 18,390 apprentice starts for 'in-scope' trades and professions:

- 1. How many of these apprenticeship starts were level 2 trade occupations?
- 2. How many of these apprenticeship starts were level 3 trade occupations?
- 3. How many of these apprenticeships were higher than level 3?
- 4. How many level 2 trade apprenticeships were completed in the same period?
- 5. How many level 3 trade apprenticeships were completed in the same period?
- 6. How many apprenticeships above level 3 were completed?
- 7. How many of the 18,390 apprenticeships were 'CITB Apprentices'?
- 8. How much was paid to the CITB in the period by organisations providing apprenticeships such as FE colleges for the support of CITB apprentices?
- 9. How many organisations such as FE colleges made payments to the CITB?
- 10. How many of the 18,390 were employed by shared apprenticeship schemes, levy payers training for more than their own needs, agencies?
- 11. How many employers in total registered the 18,390 apprenticeships?
- 12. What processes does the CITB have in place for monitoring the destination of apprentices when they complete their apprenticeship?

My response is as follows:

CITB only holds the level of detail you have requested for CITB Apprenticeships. If you require information on all Construction Apprentices you should ask the Data Services in each nation, ESFA for England, SDS for Scotland and Welsh Government Apprenticeship for Wales.

- 1. CITB Level 2 starts 2,274
- 2. CITB Level 3 starts 2,542
- 3. CITB Higher than Level 3 starts 24
- 4. CITB Level 2 Completions 3,521
- 5. CITB Level 3 Completions 2,555
- 6. CITB above Level 3 Completions 11
- 7. 5,011 (27%) of the 18,390 quoted in the 2018/19 Annual report and Accounts were CITB Apprenticeships.
- 8. Nil
- 9. None
- 10. 142 in Shared Schemes facilitated by CITB Apprenticeships
- 11. 2,355 Employers employing 5,011 Apprentices
- 12. CITB uses an exit review to determine destination
