Roof Sheeting and Cladding Apprenticeship Standard is available at Level 2.

General support for the roofing sector:

CITB has supported the roofing and cladding sector through specialised roofing training groups and we would be happy to put you in touch with your nearest group.

We as an organisation continue to work with the roofing and cladding sector regrading skills gaps. For example, we have worked in the West Midlands to understand the skill provision gaps and this has resulted in CITB supporting a routeway application of £57,000 of funding to develop roofing and cladding apprenticeship and training provision. We continue to work with employers and training providers to support the needs of the sector and understand how we can develop local solutions.

The recent Roofcert programme established professional standards for all roofing disciplines. Bringing together a cross industry partnership to create and direct a unified National Workforce Development Programme. Establishing and promoting Industry wide standards for all roofing disciplines through an "Accredited roofer" programme that will act as a baseline for the sector and that will professionalise the industry. The aim of the programme was to gain 200 roofer accreditation - work based recorders, 60 instructors and 10 skill auditors - CITB funded the programme £2.9 million.

Outside of this response to your Freedom of Information request, we would suggest you contact us so that we can arrange a meeting with one of our team to speak to you about your specific training needs and support you to access funding or grant for those needs?
