05/09/18	The first meeting of the National Working Group (NWG) for Construction Site Management (CSM) and Construction Site Supervision (CSS) was held and Members agreed the Terms of Reference for the NWG, noted the project outline, agreed future meeting dates and commenced the review of the NOS. 02/10/18	The 2 nd meeting of the NWG was held and the Chair reported that he had contacted a number of people in regard to the NOS review project, specifically organisations involved in the development of the Apprenticeship Standard for Construction Site Management and Construction Site Supervision, to ensure there was synergy between all the developments in these occupational areas. Members completed the review and revision of VR700 and started to look at the corresponding NOS in the Construction Site Management suite. Notes from the meeting are available on request.

Members considered feedback received from SQA Accreditation and whilst they appreciated the comments Members agreed that the wording of the Overview should remain. Members continued the review of VR726 in the Construction Site Management suite to ensure there was a distinct difference between the job functions in the management NOS and the supervision NOS.
