Thank you for contacting CITB requesting information under the Freedom of Information Act (FOIA). Your email, dated 12th January 2023, asked for the following information:

 - 1st April 2022 – present day

The response is as follows:

CITB does not carry out quality assurance for recognised standards, the expectation is that the organisation that has given approval to deliver their product will quality assure the ATO. Initial approval requires the ATO to share their current quality assurance status and evidence their good standing. This can be done through EV reports for the particular product as well as a requirement to inform CITB of any changes to their organisation including quality issues.

CITB has carried out assurance work that led to notifications to the recognised organisations for 8 centres where malpractice/maladministration or fraud was suspected. This work was carried out in line with paragraph 26 of the Requirements for Approved Training Organisations document.
