

#### Overview of the new commission

- Commission providers to develop and deliver a programme of specialist applied-skills not currently offered or in development for Apprentice Standards.
- Over the next 3 years CITB is expecting to fund this programme with up to £4.5m.
- Specialist qualification Lots will be awarded through mini-competitions on the Dynamic Purchasing System (DPS).
- 12-month contracts will be awarded in line with proposed forecasts and as agreed with CITB.
- Eligibility for Travel to Train funding (80% accommodation costs & travel costs over £30, subject to meeting requirements)



### Mini-competitions for Specialist Lots

- Potential providers can apply to the DPS at any time

- All DPS approved providers will receive an invitation to each mini-competition
- Specialist Lots have been grouped into three blocks with phased release dates
- Each mini-competition will include:
  - Lot Questionnaire (Delta)
  - Guidance & Evaluation Criteria (PDF document)
  - Lot specification (PDF document)
  - Contract for provision of services & standard templates
  - FAQs (if required)
