Our response is as follows:

There have not been any new Training Groups formed for several years. If CITB were to set up any new Training Groups a new application process would be required to meet the needs of CITB now.

• Clarify the process (if any) for initial and ongoing auditing / monitoring of CITB Training Groups

Local Training Group (LTG) & Regional Specialist Training Group (RSTG) Monitoring

LTGs report quarterly to CITB against a metric to identify performance against the Deliverables and Key Outcomes which are agreed between the LTG and CITB and set out in their MOU. The LTG must deliver against the following strategic outcomes:

- Value for Money
- o Training Delivery
- o Accessibility
- Training Quality

Some RSTGs will also deliver against the following strategic outcomes:

- o Increase the recruitment of new entrants to the sector
- Upskilling the current sector workforce
- o Improve the training provision infrastructure
- Increase the supply / availability of trainers
- Influence and / or broker services

Each Deliverable is RAG rated meaning it will be given the rating of either Red, Amber or Green ("RAG"). Red indicates the LTG/RSTG is not meeting their Deliverables, Amber indicates the LTG/RSTG is close to meeting their Deliverables and Green means that the LTG/RSTG has with met or exceeded their Deliverables.



National Specialist Training Group (NSTG) Monitoring

NSTGs report quarterly to CITB against a metric to identify performance against the Deliverables and Key Outcomes which are agreed between the NSTG and CITB and set out in their MOU. The National Specialist Group must deliver against the following strategic outcomes:

- Increase the recruitment of new entrants to the sector
- Upskilling the current sector workforce
- Improve the training provision infrastructure
- o Increase the supply / availability of trainers
- Influence and / or broker services

Each Deliverable will be RAG rated meaning it will be given the rating of either Red, Amber or Green ("RAG"). Red indicates the NSTG is not meeting their Deliverables, Amber indicates the NSTG is close to meeting their Deliverables and Green means that the NSTG has with met or exceeded their Deliverables.
