Freedom of Information Request 08 2019

Thank you for contacting CITB requesting information under the Freedom of Information Act (FOIA). In your email, dated 21 May 2019, you asked:

- 1. The number of cases of CSCS card fraud reported to CITB in the 2016/17, 2017/18 and 2018/19 financial years, and so far in 2019/20, respectively;
- If this information is held (and provision of it will not lead to this request exceeding the time limit), how many reports were received during those periods in relation to CSCS card fraud within the following London boroughs: Havering, Tower Hamlets, Newham, Barking and Dagenham, Redbridge, Hackney, Islington, Brent, Camden, Westminster, Haringey, Barnet.
- 3. The names and locations of any test centres closed in the above periods as a result of CSCS card fraud investigations, and the dates of closure;
- 4. Excluding personal data, the names and locations of any known third parties involved in the procurement or provision of fraudulent CSCS cards that have ceased to operate in the above periods, as a result of CSCS card fraud investigations.

My answers are as follows:

CITB acts as a service provider to CSCS and therefore does not 'hold' information under the Freedom of Information Act. CITB does however have a Fraud Team and I have below provided the information CITB holds.

1. The number of cases of CSCS card fraud reported to CITB in the 2016/17, 2017/18 and 2018/19 financial years, and so far in 2019/20, respectively;

2018	147
2019 – to April	36

These figures relate to the number of CSCS cards which, following investigation by the CITB Fraud Team, have found to have been acquired by fraudulent means.

2. If this information is held (and provision of it will not lead to this request exceeding the time limit), how many reports were received during those periods in relation to CSCS card fraud within the following London boroughs: Havering, Tower Hamlets, Newham,



Barking and Dagenham, Redbridge, Hackney, Islington, Brent, Camden, Westminster, Haringey, Barnet.

CITB does not hold the information to be able to answer this question.

3. The names and locations of any test centres closed in the above periods as a result of CSCS card fraud investigations, and the dates of closure;

CITB does not hold the information to be able to answer this question as it does not investigate test centres for only CSCS fraud. CITB Investigations are usually related to the Health, Safety & Environment Test.

To give some information, the numbers and locations of the Test Centres which have been closed over the last few years is shown below.

4. Excluding personal data, the names and locations of any known third parties involved in the procurement or provision of fraudulent CSCS cards that have ceased to operate in the above periods, as a result of CSCS card fraud investigations.
