4. Start date & duration of framework/contract?
5. Could you please provide a copy of the service/product specification given to all bidders for when this contract was last advertised?
6. Is there an extension clause in the framework(s)/contract(s) and, if so, the duration of the extension?
7. Has a decision been made yet on whether the framework(s)/contract(s) are being either extended or renewed?



8. Who is the senior officer (outside of procurement) responsible for this contract?

1. At a high level the KPI's are based on accuracy and speed of response and resolution to issues
2. There was no PQQ, the new procurement was for a single supplier not a framework. This was an open tender the suppliers who took part were Cymen, calan cyfyngedig, Lingvo House language services limited, King of translations ltd, from to limited, Yazyk Limited
3. The contract spend to date is £36,822
4. 01 November 2020 for 1 year with two options to extend for 12 months at a time, this contract will end on October 31st 2023
5. The tender details are located in Appendix 1, with all of the information
6. Yes, the final extension lasts until 31 October 2023
